

National PID Strategy and Roadmap Strategic Advisory Group Terms of Reference

The members of the Strategic Advisory Group will:

- 1. Provide strategic advice to the ARDC on the overall implementation of the National PID Strategy and review the Strategy statement as required.
- 2. Provide strategic advice on the development, implementation and review of the Roadmap, including the Action Plans and the associated tools. The Roadmap will be developed/extended on an annual basis. Performance against plans will be reviewed annually.
- 3. Provide strategic advice on the development, implementation and review of the national PID service model.
- 4. Advise on strategies for gaining the engagement and commitment of key stakeholders in the implementation of the Strategy and Roadmap.
- 5. Act as advocates for the National PID Strategy and Roadmap.
- 6. Act in accordance with the <u>ARDC Code of Conduct</u>.

Decision making

The Strategic Advisory Group has no decision-making or financial powers over - or responsibilities for - the ARDC or the implementation of the Strategy and Roadmap.

Roles and responsibilities

Members of the Strategic Advisory Group can expect:

- To be provided with relevant information in a timely manner
- To be alerted to relevant potential risks and issues as they arise
- Open and honest discussions
- To meet virtually, normally in February, July and November each year.

The ARDC will convene and support the work of the Strategic Advisory Group.

Should they be unable to attend a meeting, members are requested to nominate an alternate representative from the group or organisation that they are representing.





Meetings

Meetings will be scheduled on a quarterly basis by ARDC and will be held virtually using the Teams platform unless otherwise advised.

Meeting agenda's (topics for discussion) will be prepared by ARDC and circulated to members beforehand along with a call for additional items. Interim meetings may be convened at any time as needs arise.
